RMKS/1. PURPOSE: THIS MSG ASSIGNS UNITED STATES AIR FORCE (USAF) AS THE LEAD AGENT FOR JOINT PUBLICATION (JP) 3-40, JOINT DOCTRINE FOR COUNTERPROLIFERATION (CP) OPERATIONS. J5 IS ASSIGNED AS THE JOINT STAFF DOCTRINE SPONSOR.

2. BACKGROUND: DURING THE 26-27 APRIL 2000 JOINT DOCTRINE WORKING PARTY (JDWP), MEMBERS AGREED TO A REQUIREMENT TO DEVELOP JOINT DOCTRINE FOR CP, AND DESIGNATED IT AS JP 3-40. THE JDWP PROPOSED THAT:

A. JP 3-40 WILL PROVIDE OVERARCHING GUIDANCE ON COUNTERPROLIFERATION.

B. JP 3-40 WILL BE "UNCLASSIFIED." IF CLASSIFIED INFORMATION IS ESSENTIAL TO JP 3-40, THIS INFORMATION WILL BE PUBLISHED IN CLASSIFIED APPENDICES VICE CLASSIFYING THE BASIC PUBLICATION.

C. JP 3-40 WILL BE DEVELOPED IN ACCORDANCE WITH STANDARD DOCTRINE DEVELOPMENT PROCEDURES.

D. JP 3-40 WILL APPLY TO THE EMPLOYMENT OF EXISTING MILITARY CAPABILITIES ACROSS THE RANGE OF MILITARY OPERATIONS.

3. SCOPE: THIS PUBLICATION SETS FORTH THE PRINCIPLES TO PLAN FOR AND CONDUCT MILITARY ASPECTS OF CP OPERATIONS. THIS INCLUDES THE EXISTING CP CAPABILITIES IN AREAS OF COUNTERFORCE, ACTIVE DEFENSE, PASSIVE DEFENSE, AND CONSEQUENCE MANAGEMENT. ADDITIONALLY, THIS PUBLICATION WILL ADDRESS MILITARY ACTIONS TO PREVENT PROLIFERATION AND MILITARY SUPPORT TO NONPROLIFERATION EFFORTS. JP 3-40 WILL PROVIDE GUIDANCE ON THE APPLICATION OF THESE PRINCIPLES TO JOINT, MULTINATIONAL, AND INTERAGENCY OPERATIONS. THIS PUBLICATION WILL COMPLEMENT JOINT DOCTRINE PROMULGATED IN JP 3-11, "JOINT DOCTRINE FOR OPERATIONS IN NUCLEAR, BIOLOGICAL, AND CHEMICAL (NBC) ENVIRONMENTS," 11 JULY 2000.
